

Proof of Financial Support



International applicants who intend to study in the United States on an F-1 or M-1 student visa are required by federal law to provide *Proof of Financial Support* in the form of an official Bank Statement or Bank Letter as a compulsory part of their application for admission. This Statement or Letter must demonstrate adequate *Proof of Financial Support* to cover at least one full academic year (9 months) of tuition & fees, cost of living, incidentals, books & supplies, and health insurance.

- ▶ International applicants to Kansas City Kansas Community College must provide *Proof of Financial Support* in the ***minimal*** amount of **at least \$24,225.00USD** as a compulsory part of the application for admission.

Proof of Financial Support Requirements:

- ↪ It may be in the form of an official Bank Statement or an official Bank Letter
 - Bank Statements must list the bank's information, account holder's personal information, account information, and the account's total current balance.
 - Bank Letters must be issued on official bank letterhead – bearing the bank's logo and detailing the bank's information – and include the account holder's personal information, account information, and the account's total current balance.
 - There is a sample Bank Letter on the back of this page.
- ↪ It may be in your local currency or in USD
- ↪ It must be in English
- ↪ The date of the total available balance cannot be older than 1 year from the date your studies would begin at KCKCC
- ↪ The funds must be readily accessible
 - Real estate, stocks, investments, payroll statements, etc... are **NOT** eligible
- ▶ If the Bank Statement or Bank Letter is not from your personal bank account and is not in your name, the financial sponsor who provided the Statement or Letter must also complete and submit the [Affidavit of Support Form](#) (available online by clicking the link above), verifying their commitment to financially sponsor you for the duration of your studies at KCKCC.
 - ↪ The *Affidavit of Support Form* **must** be notarized or attested.
 - Forms that are not notarized or attested can **NOT** be accepted.
 - ↪ The Financial Sponsor's name that is printed and signed on the form must **exactly** match the name that appears on their Bank Statement/Bank Letter.
